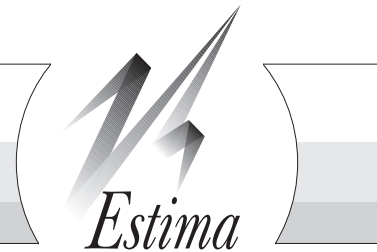

Single-User UNIX and Linux

Version 8.1



Our popular RATS econometrics software is also available for UNIX and Linux platforms.

The UNIX version of RATS supports all of the same commands as WinRATS and MacRATS, so programs can be easily ported from one platform to another. RATS format data files can also be ported without doing any translation.

The UNIX version also includes the same powerful interactive editing environment available for Windows and Macintosh. This environment operates much like an ordinary text editing program, but it allows you to develop, test, and execute RATS instructions, save and re-run complete programs, and work with graphs.

It also gives you access to more than thirty menu-driven *Wizards* providing point-and-click access for many tasks, helping make RATS easy to learn and use.

This form provides pricing for licenses to use RATS on one or more *single-user* workstations. If you want to run RATS on a workstation which acts as a server for *multiple* users, please see our “Multi-user UNIX” order form.

For most platforms, RATS is supplied as C language source code, so you must have ANSI standard C and C++ compilers to install RATS on your machine. To use the interactive interface, you will also need X Windows support and have the Motif libraries installed on your system.

For Linux systems, we do provide pre-compiled executable files, so it is not necessary to compile the software yourself on most Linux systems (source code is optional for Linux).

RATS is supplied on a single CD ROM. Each license includes the following:

- The RATS source code (optional for Linux)
- One set of the RATS User’s Manuals
- Copies of the documentation in PDF format
- “Make” files for compiling and linking the source
- Hundreds of example programs and datasets
- Procedures (subroutines of RATS commands)

Professional Version

In addition to the standard version of UNIX RATS, we also offer a “Professional” version, which adds three additional features:

- The ability to read and write data from FAME database files. Requires FAME’s HLI interface.
- X11 seasonal adjustment. This integrates our implementation of the Census X-11 seasonal adjustment procedure into RATS as a built-in instruction.
- Support for reading CRSP® (Center for Research in Security Prices) data.

Version 2 of the CATS in RATS cointegration analysis procedure, developed by Dennis, Hansen, Johansen, and Juselius of the University of Copenhagen, is also available for UNIX RATS.

RATS requires approximately 100 megabytes of disk space for a complete installation, including all documentation and sample programs. RATS dynamically allocates memory as allowed by the system.

If you are purchasing a *new* license (except for executable-only Linux), you must return a signed non-disclosure agreement with your order. Contact us if you need a copy.

Prices for both new licenses and updates to existing licenses are provided on the opposite side of this form.

Please note that RATS is *not* leased the way some mainframe packages are—you pay a one-time purchase price for a license to use RATS. You do not need to make additional payments to continue using the software.

Significant updates are made available at a reduced price to licensees, but you are not required to update.

We also offer an annual Update Subscription service for those users who would like to receive updates automatically. Please contact Estima for details.
